ASSUMPTION OF RISK AND RISK OF ACCIDENT

Buyer represents that the Member (Buyer and Member may be the same person) is covered under Buyer's own insurance policies to cover any personal injuries to them personally or which they may cause to others. The Buyer and Member agree to deal directly with Buyer's own carrier and not the gym on any claim. Buyer acknowledges that the membership cost reflects the savings due to the fact that the Buyer and Member provide their own insurance and not The Gym. ANY PERSON USING THE EQUIPMENT OR THE FACILITIES DOES SO AT THEIR OWN RISK. It is further agreed that all exercises including the use of weights, number of repetitions, and use of any and all machinery, equipment, and apparatus designed for exercising shall be at Buyer and Member's sole risk. Notwithstanding any consultation on exercise programs which may be provided by Gym employees, it is hereby understood that the selection of exercise programs, methods and types of equipment, shall be Buyer and Member's entire responsibility, and the Gym shall not be liable to Buyer or member for any claims, demands, injuries, damages, or actions arising due to injury to Buyer or Member, their person, or property arising out of or in connection with the use by Buyer or Member of the services and facilities or the premises where the same is located and Buyer and Member, hereby holds the Gym, its employees and agents harmless from all claims which may be brought against them by Buyer or Member or on either of their behalf for such injuries or claims aforesaid. Buyer and Member shall also examine each piece of equipment prior to use and refrain from use and report the same if there is any indication that the equipment has been subjected to abuse, damaged, or is in an unsafe or potentially dangerous condition. Buyer and Member have a duty to exercise care for the protection of themselves and other members while using the premises. If any accident is caused by defect or faulty design of equipment, the injured party will direct any claim against the manufacturer, holding the Corporation harmless, subjugate their rights, if any, to the Corporation. Buyer or Member, if injured or Member's representative if Member is unable to do so, must complete, sign, and deliver an incident report within (72) hours of the time of the occurrence. As to overexertion's, stresses, and Members own physical condition, and any other concerns; or, that Buyer and Member will seek such advice; or, that Buyer and Member assume the risk of proceeding without such advice. Buyer and Member represent that they have read and agree to abide by the rules and regulations of the Gym. Buyer and Member agree to report any violation of the Rules and Regulations by other Gym users to employees of the Gym. Notwithstanding the fact that every Gym user has agreed to abide by the Rules and Regulations, Buyer and Member recognize that Gym employees cannot monitor every Gym user for a violation of the rules. Gym shall not be liable to Buyer or Member for any claims, demands, injuries, damages, or actions arising due to breach of Gym rules by other Gym Members or users or any other conduct of Gym Members or users. Failure of Buyer or Member to comply with this contract or any Rule or Regulation shall be cause for revocation of membership without notice and without any liability for refund.
